### PRELIMINARIES

(2 sessions)

Saturday, Nov. 5, 11 a.m.

- Round robin
- Ten flights of eight
- Race to 5, winner's choice
- Single foul, 40 sec. shot clock
- Top two per flight to finals
- Five wild card finalists

### FEEES & REQUIREMENTS

ENTRY FEE: \$95.00

GREEN FEE: \$10.00

Early entrants have choice of session in preliminaries. Entry time judged by date and time of either postmark or hand delivery.

### MISSOURI RESIDENTS ONLY! AMATEURS ONLY!

Valid Missouri driver's license or other PICTURE I.D. required for proof of residence. NO EXCEPTIONS! Tournament committee decides resident and amateur status.

Tournament Director reserves exclusive right to buy back and reassign any canceled or forfeited berth.

### SEMIFINALS:

Sunday Nov. 6, 10 a.m.

- Round robin
- Five flights of five
- Race to 5, winner's choice
- Top 2 per flight & 2 wild cards advance

**FINALS:** Twelve player double elimination playoff (4 byes). Race to five in winners bracket. Race to four in loser's bracket.
